Every effort will be made to accommodate your mare's breeding time-frame; however, it is the mare owner's responsibility to keep in touch with West Elk Equine so that your veterinarian and ours can get your mare in foal on a timely basis. Failure to adhere to these arrangements may result in missed heats and delayed shipments, at the mare owner's expense. A veterinarian knowledgeable in successful insemination techniques must oversee off site inseminations, in order to maximize the potential of a

- 5. If a mare dies or is deemed unfit to breed during the breeding season, a substitute mare, approved by the stud owner, may be bred without any additional breeding fee. Mare must be owned or leased by the same mare owner as on this contract.
- 6. The mare owner agrees to have the mare checked by ultrasound no later than 18 days after insemination. If ultrasound is unavailable, mare owner agrees to have the mare checked for pregnancy by licensed veterinarian within 30 days of insemination. Mare owner agrees to provide West Elk Equine with the results of the pregnancy exam no later than 30 days after insemination. Breeder agrees to diligently try to settle mare; however, if mare fails to settle, for any reason, mare owner will hold breeder blameless. Mare owner agrees to give breeder ample opportunity to settle mare, including a minimum of 3 breeding cycles.
- 7. This Contract contains a 'Live Foal Guarantee'. A live foal is described as a newborn foal that stands and nurses without assistance. If foal is born dead, there are return privileges for the 2020 season only if Breeder is notified within 7 days and receives a veterinarian's statement confirming death. If after being pronounced "safe in foal', the mare should miscarry, abort or prove barren after leaving the breeder's premises, mare owner has the privilege to return her for rebreeding during the current breeding season, or the following year, 2020.
- 8. If the mare owner fails to rebreed the mare the following year, then any and all fees become forfeited, the right to rebreed is cancelled and the stallion owner is released from all further obligation of this contract, unless otherwise agreed in writing and signed by both parties.
- 9. A 'Breeder's Certificate' will be issued for the foal conceived by this mating when stud fee, veterinarian expenses and all other expenses have been paid in full and when mare has produced a live foal that stands and nurses by this mating. If you are breeding a fox trotter mare and want to register the foal through MFTHA made sure to send in an Application for Mare Permit your mare when breeding with shipped semen. Dunny is certified through MFTHA to ship semen. Both parties agree that West Elk Equine, the breeder, their agents or employees are not liable for death, sickness and/or accident including consequential damages caused to the mare and/or foal unless such death, sickness and/or accident was by the willful and wanton gross negligence of the breeder. It is further agreed that should the stud die, be sold by the owner, or become unfit for service, prior to settling the mare, that the breeding fee less shipping will be refunded, if it has been paid in full, thereby canceling this entire contract; or, if mare dies or becomes unfit to breed, the breeder has the option to accept another mare as a replacement. This contract is non-assignable and non-transferable.
- 10. The mare owner is responsible for all personal property taxes and full insurance on mare and foal (if desired).

It is the mare owner's responsibility to order a shipment at least 24 hours in advance.

- 1. Semen will be sent via Fed-EX (next day arrival) at \$200 per shipment. First shipment is included with breeding fee.
- 2. If Fed-Ex delivery is not available within a 24-hour period, additional notice will be required. Mare owner should check with Fed Ex for weekend, holiday delivery or customer pickup.
- 3. West Elk Equine shall not be responsible for the COSTS arising from shipments lost, damaged, or delayed in transit, or condition of cooled shipped semen upon delivery. We have no control of the shipment after it leaves our custody.
- 4. Semen shipped in an Equitainer ensures you receive the best possible quality. If you receive your shipment in and Equitainer, the Equitainer MUST be returned at your earliest convenience not to exceed 7 days. If Equitainer is not received within 2 weeks after original delivery date Owner's card will be charged \$300 to replace the Equitainer. (New Equitainers cost \$375)
